# **Secretary/Treasurer Report (Christopher Blazic):**

- Approved February 22, 2023 Board Meeting Minutes.
- Reviewed the February 2023 Financials. They cannot be approved until the 2022 audit is completed.
- Chris indicated that he will be conducting a monthly Meet and Greet with the residents.

# **President's Report (Jeffrey Poth):**

- Addressed Lake Access Rights for Blooming Dreams Development/ Deep Wood Lakes/Seth Maurer- Legal action continues to proceed. There is a 4/5/23 court date scheduled.
- The DEP has received the design options for the dam remediation. The project is at a standstill until the DEP approves one of the designs.
- BMLA is awaiting the Luzerne County Council award vote on 3/28/23 on the \$500,000 grant application for the Stormwater Infrastructure project.

# **Department Reports- Manager Reports (Cody Hess & Karen Amici)**

- Restaurant
- The Restaurant lost \$5.9K in February. This is \$370 under budget. February sales are up vs. 2022. The Restaurant is currently losing \$4.5K less than budgeted in 2023.
- Maintenance
- Maintenance has finished painting the bar. They have begun painting the gym.
- New stop sign has been installed at the corner of Grouse Ridge and Covey Ln.
- Maintenance repaired/replaced broken blinds in the community room.
- Wet slips are scheduled to be installed on or around April 15th.
- Public Safety
- Sticker sting was conducted at the main entrance for expired stickers.
- Expired vehicle stickers as a result of dues payment delinquencies will continue to be enforced.
- Speeding and stop sign violations will remain a focus for Roving Patrol.
- Code Enforcement
- Code Enforcement is currently focusing on blocked driveway pipes and untidy properties.

#### Recreation

- Finance (Tina Evans)
- The Committee will meet on 3/29/23 to review the February financials.
- Public Safety (David Wright)
- The Committee has re-organized. Dave Wright is the Chairman and Brian Rozanski is the Vice-Chairman. The Committee is working on bus stop safety measures, analysis of Roving Patrol hours and technology for license plate scanning.
- Volunteer Committee (Blanche Kania)
- The Committee is looking for volunteers for the flower sale for Palm Sunday weekend. The Committee is planning the Strawberry Social for June. The Committee is looking for any young adults who need to do community service hours for Graduation, Confirmation, etc. to contact the Committee.
