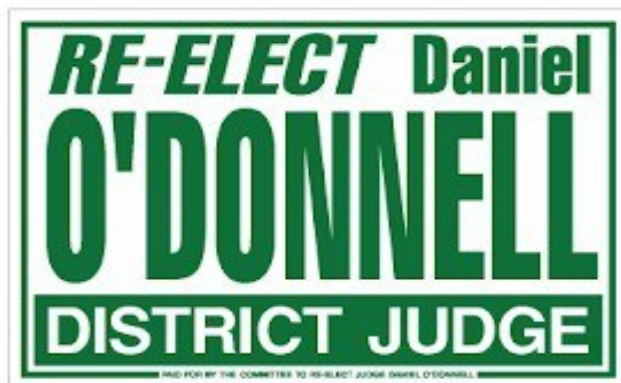

Lorine Ogurkis, an attorney, non-profit founder and mother of 5 children proudly announces her intention to run for Magisterial District Judge in District 11-3-03. "I have dedicated my entire career to standing up for children and families in need" said Lorine Ogurkis. "Sitting as a Magisterial District Judge, I will be honored to do my part to make sure our home is a safe and secure place where families could thrive" continued Ogurkis.

Lorine has been on the front lines supporting our area's youth. As Co-Founder of Brandon's Forever Home, she has dedicated countless hours offering a hand to foster children, many of whom have no family or support. "I have been blessed to have 5 children, 2 of who have been adopted from foster care" said Ogurkis. "When I saw the beauty and joy that these kids have brought to our life, I knew there were others out there who needed help. Someone had to do something, so with the help of family and friends, we purchased a home in Hazleton and founded Brandon's Forever Home to those foster kids in need" continued Ogurkis. To date, Brandon's Forever Home has helped dozens of foster kids with food insecurity, educational resources and home placements.

Lorine hopes to bring that same passion to her role as Magisterial District Judge. "I have always been a huge supporter of law enforcement and families. I cannot sit idly by while I read about how our area has changed" said Ogurkis. "Every person will have a fair shake in my courtroom and every charged with a crime will be held accountable if required."

Lorine was born and raised in Hazleton, PA and is the daughter of Richard and Claudette Angelo. She is a graduate of Bishop Hafey High School. She obtained a Bachelor of Science Degree from Marywood University and a Juris Doctorate Degree from Penn State University-The Dickinson School of Law located in Carlisle, PA. After completing Law School, Attorney Ogurkis returned to the area and was employed by Eagle Rock Resort serving as Vice-President/General Counsel of Double Diamond and Eagle Rock Resort.

She is admitted to practice by the Supreme Court of Pennsylvania to the bar of the Commonwealth of Pennsylvania and the State of New York. Attorney Ogurkis most recently opened her own law practice in Hazleton, Ogurkis Law specializing in family law, real estate, wills and estates, and adoptions.

Along with her professional achievements, Attorney Ogurkis has served on the Board of Directors for the Hazleton Area Public Library, as Secretary for the Board of Directors for the Hazleton Area Volunteers, and the Assistant Director for Hazleton POWER and Founder of We Are Hazleton benefiting Hazleton police. She has served as a member of the Board of Directors for the Great Hazleton Chamber of Commerce, CASA Luzerne County, and Chairman of the Advisory Board of Children and Youth. Attorney Ogurkis is the 2016 recipient of the Congressional Angels in Adoption Award, along with the Mary Bevivino Award presented in 2016 by the Luzerne Foundation, and the PA Swan Philanthropic Award benefitting children in foster care.

Lorine currently resides in Conyngham, PA with her husband Michael and their 5 children.

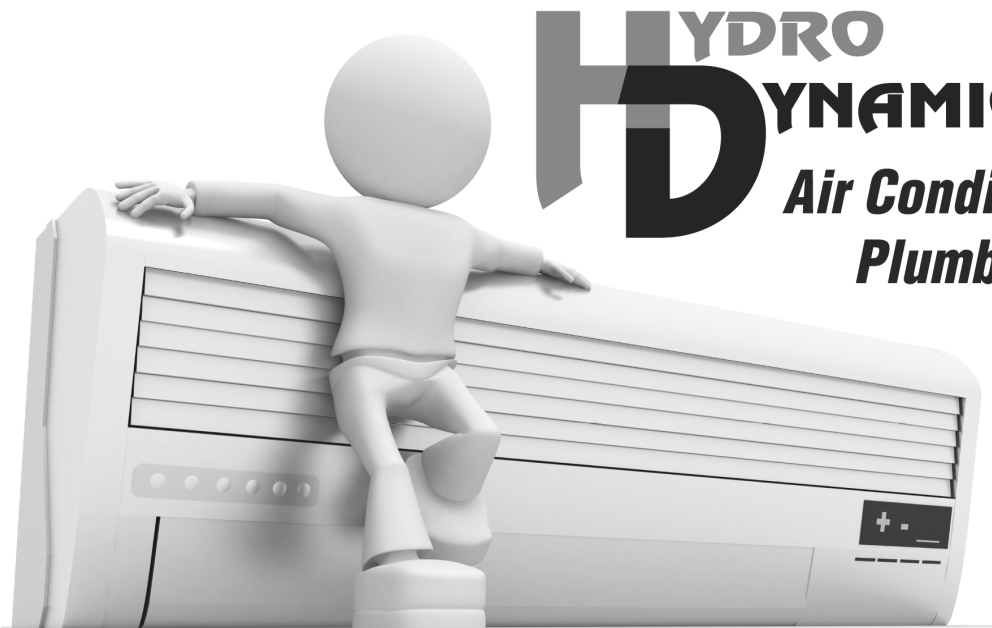
