## Secretary/Treasurer Report (Christopher Blazic):

### **President's Report (Jeffrey Poth):**

- Addressed Lake Access Rights for Blooming Dreams Development/ Deep Wood Lakes/Seth Maurer- Legal action continues to proceed.
- The DEP has received the design options for the dam remediation. The project is at a standstill until the DEP approves one of the designs. The least expensive option would be for the DEP to allow the water to overtop the dam. The final plan needs to engineered, constructed and funded. Bids will be secured for the engineering and construction phases. Funding will come from loans, grants and owner assessments. The project is expected to be completed in 2026.

- Restaurant
- The Restaurant lost \$4.6K in January. This is \$4.1K under budget. January sales are up 69% vs. 2022.
