Recreation Office. Permits will be available for pickup in the Recreation Department on September 8th.









Each year in conjunction with the Annual Meeting, the membership elects a Director or Directors. A Director serves a two (2) year term. Our By-laws provide for three (3) property owner directors and three (3) Quail Hollow Association directors, who serve on the Beech Mountain Lakes Association Board of Directors. It is their duty to attend meetings and perform the functions of the Board. Currently (1) Beech Mountain Director seat is up for election.

Only those members who are in good standing in the Beech Mountain Lakes Association are eligible to serve. Candidates must meet these requirements:

- Their name must appear on the deeded property within the Association.
- (2) They are required to meet all financial obligations. This includes dues, assessments and time payment plans that must be paid up to date.
- (3) Candidates must have three (3) property owners' signatures to endorse their nomination. TAKE NOTE: Felony convictions preclude applicants from serving on the Board.

- Restaurant (Wendy Boyer) Wendy reviewed the committee's recent activities involving menu changes, new television for the bar and installation of a new POS system.
- Recreation/Volunteer Deb Popson noted that the committee's current focus remains preparing for the Fall Festival scheduled for October 16, 2021.

#### Questions/Comments from Residents (approximately 40 individuals):

- Majority of questions and concerns involved the continuing high level of stress being placed on BML's main entrance, public safety system and amenity infrastructure being caused by the high occupancy rates and short-term nature of the rentals. Several individuals encouraged residents to attend the scheduled Butler Township appeal hearing.
- Mike Kloton (Public Safety Committee Chair) addressed residents' concerns
  regarding the "stop sign" program recently initiated. He noted that the program
  was launched in response to comments received from the survey. He also noted
  that the program is a "work in progress" and the community will be provided
  with advance notice as changes are made.
- Other Items discussed:
  - Feral cats.
  - Geese.
  - Moving "public session" to the pavilion (weather permitting) in light of upsure in Covid cases.
  - Fall leaf season.
  - Restaurant survey.
